This First Amendment to The Greenways at Hillside, Ltd. Association Declaration is made by The Master Association for the Greenways at Hillside, Inc., a Texas non-profit corporation (the "Association"), to be effective as of the date set forth below.

### **RECITALS**

- A. WHEREAS, The Greenways at Hillside Association, Inc. was formed on September 29, 1995 (the "Greenways"); and
- B. WHEREAS, The Greenways at Hillside, Ltd. Association Declaration was recorded on September 28, 1995, and imposed covenants and liens on The Greenways at Hillside Unit No. 1 and Unit No. 2 (the "Association Dec.")
- C. WHEREAS, The Master Association for the Greenways at Hillside, Inc. was formed on April 30, 1998 (the "Master Association"); and
- D. WHEREAS The Greenways at Hillside Master Declaration was recorded on May 6, 1998, and imposed covenants and liens on The Greenways at Hillside Unit No. 4 (the "Master Dec."); and
- E. WHEREAS all other property in The Greenways at Hillside has been subjected to the Master Dec.; and
- F. WHEREAS, Articles of Merger of Domestic Corporations was filed with the Secretary of State on April 9, 2001, and an Affidavit of Merger was recorded on December 14, 2022, under Document No. 2022024407 in the Official Public Records of Randall County, Texas; and
- G. WHEREAS, the aforementioned Articles of Merger and Affidavit of Merger merged the Greenways and the Master Association with the Master Association surviving;

furthermore, they intended to merge the Association Dec. and Master Dec., having few differences in drafting, with the Master Dec. surviving; and

- H. WHEREAS the Master Association wishes to clarify through ratification that Unit No. 1, Unit No. 2 and Unit No. 3 (a replat of a portion of Unit No. 2) are subjected to the Master Dec. by amending the Association Dec.; and
- I. WHEREAS, Pursuant to Section 5.3 of the Association Dec. provides that a Majority of the Members is required to amend the Association Dec.; and
- J. WHEREAS, a Majority of the Members voted to pass the amendment to the Association Dec. below; and
- K. WHEREAS, any capitalized term that is not defined herein, shall have the meaning given to such term in the Declaration.

- 1. The Recitals set forth above are true and correct and are hereby incorporated into this Amendment as if set forth at length herein.

<u>Ratification</u>. The Declaration is hereby ratified and confirmed in all respects except as amended in this Amendment.
